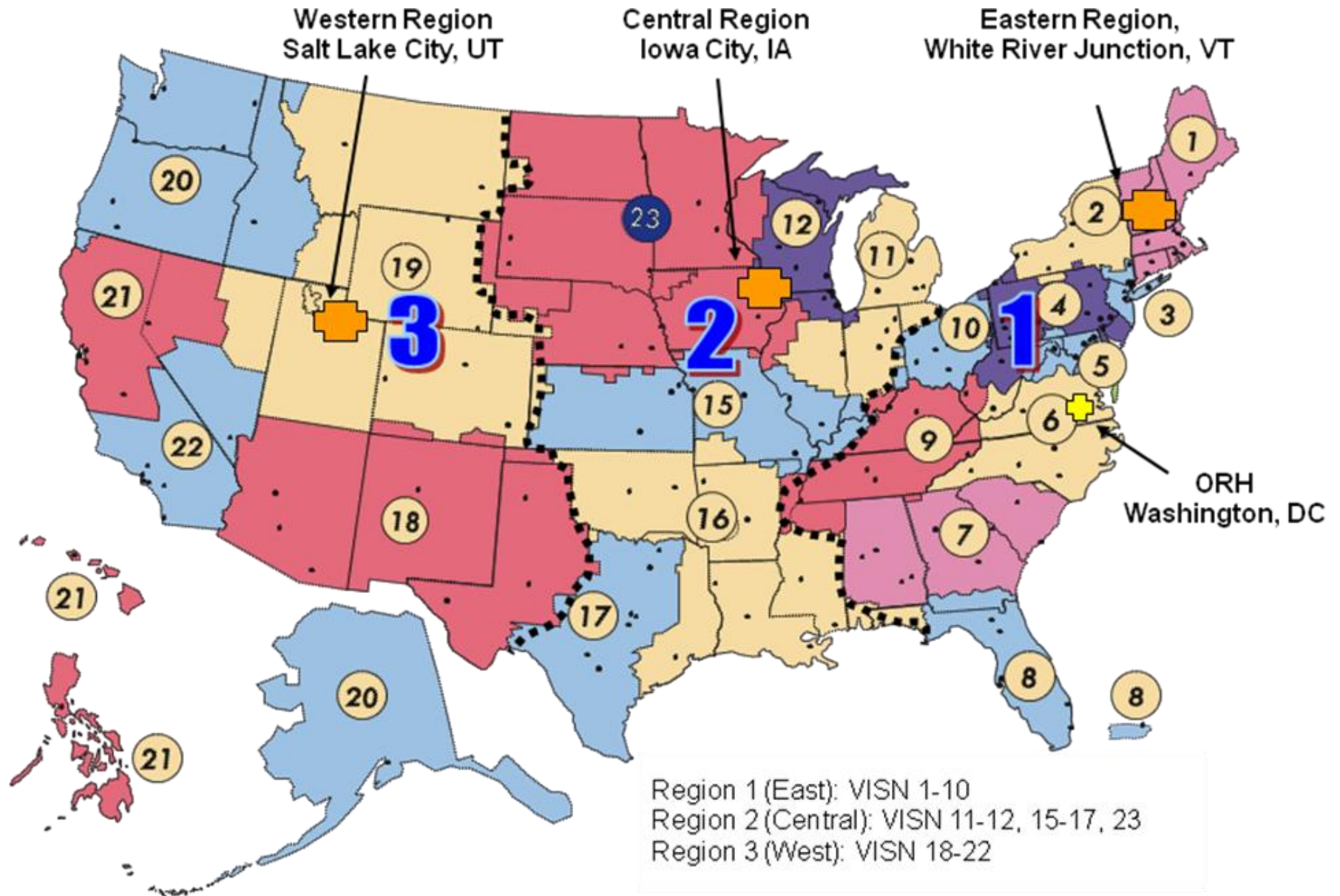

MAP 2: VA VISNs

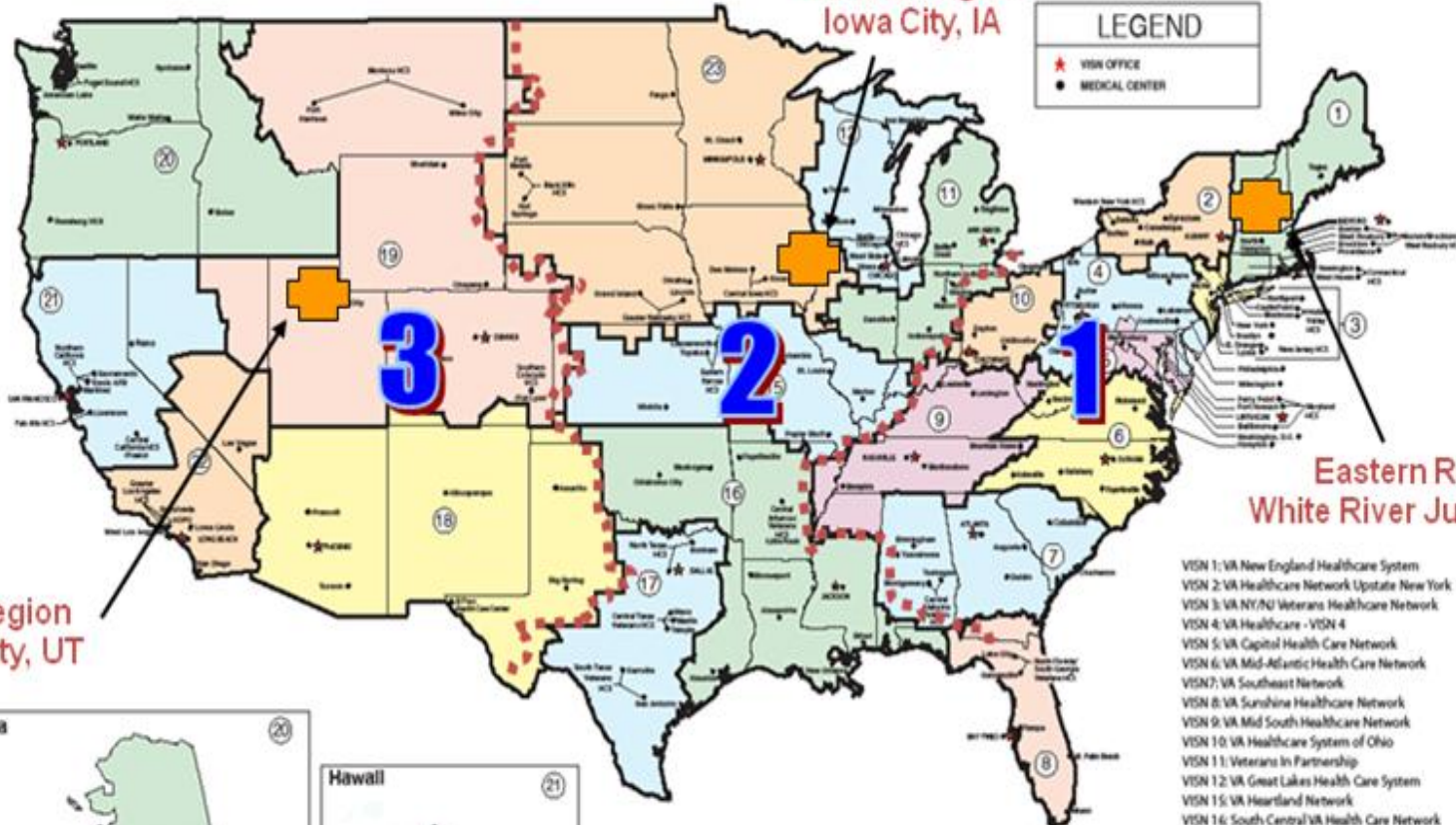

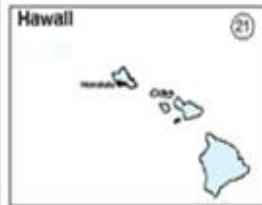
